

## **REGISTRATIONS/TUITION/WITHDRAWAL**

A non-refundable \$55 membership fee per family, will be charged to your credit card upon registration for fall. There will be NO membership fee for Parent/Tot or the Broadway Classes. The first month's tuition is due by September 1st, or at time of registration if after **SEPTEMBER 1ST.** 

Monthly tuition installments are based on a yearly tuition amount and then divided into 9 equal payments for your convenience. The monthly tuition remains the same, regardless of the number of classes in a month.

All tuition payments are due on the 1st of the month (September 2024 through May 2025) and a credit card number MUST be on file in AKADA for every account. By default, your monthly tuition payment will be automatically charged to the card on file the first of the month. A LATE FEE of \$15 will be added to the account if the card on file does not process (with the exception of stolen/lost cards).

There will be NO REFUNDS for cancellations due to weather or for classes missed due to illness. Your child is welcome to do a make-up session in another class of similar level and type. If more than 2 classes are canceled due to weather, a make-up class will be scheduled.

We understand that dance class may not be for every child. If you would like to withdraw your child from class, we MUST BE NOTIFIED IN WRITING PRIOR TO THE END OF THE CURRENT MONTH. Your request for withdrawal can be emailed to <u>info@mhdcdance.com</u> or <u>kpsoinos@mhdcdance.com</u>.

### MHDC WAIVER
